Political priorities for ageing societies in the UNECE region

What policy areas and topics may have been overlooked or inadequately addressed in regional efforts to build societies for all ages? This question lies at the heart of a current workstream of the United Nations Economic Commission for Europe (UNECE) to guide future ageing policy in the region. Between June 2024 and June 2025, national stakeholder consultations were conducted to gather diverse perspectives on this question. Participants of all ages from NGOs, civil society, academia, and governments were consulted.

The UNECE is now analysing the findings of the national consultations to update the Regional Implementation Strategy (RIS) of the Madrid International Plan of Action on Ageing (MIPAA). In parallel, this online event brings together representatives of civil society from across the UNECE region to discuss future priorities for ageing policy. Aim is to explore the challenges that ageing societies in the region are facing and to discuss how rights-based frameworks can help create inclusive, fair and sustainable societies. The event will identify key areas for action and inform the ongoing update of MIPAA/RIS and the upcoming negotiations for a new UN convention on the rights of older persons.

The event is part of the series 'An engaged civil society as engine for an age-friendly society: an international exchange', which features six online events running until the end of 2026. The series provides civil society representatives a platform for exchange and to stay informed about the latest international developments in ageing policy and the human rights of older persons.
